RELEASE AND WAIVER OF LIABILITY ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

This RELEASE AND WAIVER OF LIABILITY ASSUMPTION OF RISK AND INDEMNITY AGREEMENT (this "Release") is given by("Participant" TEEN). As a Participant, I am signing this Release for myself and anyone who may assert claims on account
of me.
This Release is also being given by ("Responsible Adult" - PARENT). I am the parent or legal guardian of the Participant, and I am signing this Release on behalf of myself; the minor Participant; and anyone who may assert claims on account of the Participant or me. Also, as the parent or legal guardian, I consent to the participation of Participant in the Youth Interactive Safety Lab ("the Event") being conducted by the National Organizations for Youth Safety ("NOYS") at Glenmont Local Park with additional sponsors and lab contributors.
Participant and Responsible Adult are collectively referred to as "Releasers"
Releasers make this agreement with NOVS for the benefit of NOVS and their affiliate companies, distributors, dealers, successors

Releasers make this agreement with NOYS, for the benefit of NOYS and their affiliate companies, distributors, dealers, successors, sponsors, and assigns, directors, officers, agents, employees and volunteers, and Glenmont Local Park; all referred to as "Releasees"

IN CONSIDERATION of being permitted to participate and/or to observe the Event, the Participant and Responsible Adult each agrees:

1. I UNDERSTAND that (a) the Event may involve operation of motor vehicles in conditions not usually encountered in normal driving, which are hazardous and involve risks of dangers of serious bodily injury and/or death, (b) there may be other risks not known or foreseeable at this time, and (c) rescue operations may increase or compound any damages or injuries.

- 2. I UNDERSTAND that such injuries could permanently change the Participant's future (and possibly Responsible Adult's future).
- 3. I UNDERSTAND that any injuries or damages may be caused in whole or in part by the negligence of the Releasees or otherwise and:
 - A. I HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the Releasees, FROM ALL LIABILITY TO the Releasers, FOR ALL CLAIMS, DEMANDS, LOSSES, OR DAMAGES.
 - B. I HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS the Releasees and each of them from ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS, LIABILITY, DAMAGE, OR COST THAT MAY RESULT FROM ANY CLAIM MADE AGAINST the Releasees by any of Releasers or by those claiming to act on behalf, or on account, of any Releaser.
 - C. I HEREBY ACCEPT AND ASSUME ALL RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS AND/OR DAMAGES.
- 4. I HEREBY agree to provide full and accurate registration information, including whether the Participant has any limitations that would make the Participant's participation in the Event inadvisable.
- 5. I HEREBY agree that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreements extends to all acts of negligence by the Releasees and is intended to be as broad and inclusive as is permitted by the laws of the Province or State in which the EVENT is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect.
- 5. The Responsible Adult has made sure the Participant understands each of the above provisions.
- 6. I UNDERSTAND that at this event or related activities the Responsible Adult and/or the minor Participant may be photographed. I agree to allow my, and/or the minor Participant's, photo, video or film likeness to be used for any purpose by the event holders, producers, sponsors, organizers and/or assigns. I acknowledge that it is almost impossible to single out one participant to not be photographed.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT FULLY. I UNDERSTAND ITS TERMS, AND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT. I AM SIGNING IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST ALLOWED BY LAW.
